

2023, was a "let's get back to normal". Not only did we see library staff issues throughout the country settle back to pre-COVID levels, but more RFPs for services were issued in 2023 than 2022. We were pleased to win the State of Texas SHAREit bid opportunity in August. The project kicked off in September 2023 and will go live with over 300 libraries this summer. The Company was also able to renew a couple of its larger contracts for terms of five years or longer.

The Company is continuing to update both SHAREit and VERSO base code to be more relevant to today's security and privacy demands. As a matter of fact, we have signed up for the StateRAMP security and verification program with Cheryl Slinkard (COO) personally leading the initiative.
